- SZC24:16 It was proposed that the Minutes of meeting of 19 August 2024 be approved: All Agreed
- SZC24:**17** Chair's Report: Cllr Chenery reported that the last SZC Southern Transport Forum met on 13 November 24. Subsequently they agreed to his request for additional traffic monitoring stations on Border Cot Lane and on the High Street between Border Cot Lane and Rackham's bridge. The next monitoring survey will be April 2025. The next forum is on 12 March. AS to submit a question via Cllr Chenery.
- SZC24:18 Review of meeting with SZC on 23 January 24 and latest SZC traffic calming drawings:

  The Group felt the meeting with SZC was useful but it was difficult to see all the details on the slide show and we still await the SZC minutes. Regarding the latest drawings (General Arrangement and Pavement & Kerbing) the Group made the following comments:
  - Sheet 1 no comments
  - Sheet 2 the first kerb build out could we see SCC's standard detail drawings? At the public engagement event we'd ask that you show a montage or picture of what the build out will look like. What will the reflective bollards look like? We welcome the widening of the west footway from the cemetery access heading north.
  - Sheet 3 can the widened footway on the west side outside the Post Office be extended further north as it stops outside No. 42 where the existing footway is very narrow? We accept this may conflict with turning movements to and from the access on the east side
  - Sheet 4 Dallinghoo Road we note the new kerb on the south side will have a 10mm upstand and the footway behind would be overlain with buff resin. Unless this is 10mm thick were it abuts the new kerbing would there be a trip hazard? We assume this has been approved by safety audit? At its west end won't the eastern protective bollard in the middle of the footway obstruct pedestrians? Delete the note "Wickham Market Pharmacy" as this has relocated.
  - Sheet 5 no comments
  - Sheet 6 no comments
  - Sheet 7 can the parking area outside No. 171 be extended further south outside No. 165 to match the existing provision? Can you calculate the number of parking places lost on the south-east side?
  - Sheet 8 retain kerb build out in location just south of Lower Street but delete kerb build out outside Roy Webb Antiques due to concerns in accessing/egressing The Drift. In all the proposed parking sections is the intention to have road markings at right angles to the kerb to mark out individual parking bays as this might not accommodate as much parking as at present? We note that the southern end of this parking section is as existing. Rackham's entrance need to determine the highway boundary across the access as Rackham's think it's the edge of the main road and may not give consent to any works within their bellmouth as their lorries have difficulty in accessing/egressing their premises. We note the proposed overlays on the eastern corner of the access are either 20mm or 30mm thick suggesting

these could be over-ridden? The widening of the footway on the north side east of Rackham's access up to the Fiveways roundabout shows new kerbing chased into the road with only a 50mm upstand and only a 20mm footway overlay. We would have expected a 100mm kerb upstand.

- Sheet 18 its anticipated that several displaced vehicles from the High Street may want to park on Border Cot Lane. There are intended parking bays on the north side connected to a new footway. Can street lighting be provided from the High Street to the west end of these parking bays for pedestrian safety? What's to stop parking on the north side within parts of the visibility spays to Riverside View industrial estate?

General comment – the Committee repeated its disappointment that SZC's design will lose a large number of on-street parking spaces on the High Street and assumes those vehicles would find alternative parking provision which the Committee considers this doesn't readily exist nearby.

#### SZC24:**19** Public engagement event – the Committee commented as follows:

- Needs to be well advertised in advance. Many residents haven't followed the evolution of the design and its impact. Suggest a letter or leaflet drop by SZC to all properties plus posters, social media and parish council newsletter
- Timing suggest a Friday pm and evening and a Saturday morning
- Exhibition to be staffed by WSP and SZC plus parish councillors
- Drawings to be displayed around the room with a key plan at the start
- Visualisation or montages of kerb build-outs, gateways etc would be useful
- Could the outlines of the existing buildings, accesses etc be bolder so people can work out where they are?
- The Committee favours an exhibition of the drawings around the room but at a preadvertised time to have WSP/SZC staff on a top table with the public seated to allow everyone there to hear questions and answers
- Need to extend invitations to Pettistree and Hacheston parish councils as some of the works abut or are in their parishes.
