Parish Council Purchase Order has been drafted for the value of £1750.00 to Castleview Charitable Services to review our previous grant application of December 2024 and prepare new SZC re-grant application for £600K collation of additional documentation recommended by SZC grant funding panel prepare new application for issue by 20th July 2025

Modernisation Team have developed an initial DRAFT Gantt Project Timing Programme fundamentally driven by receiving full grant funding from SZC grant review panel on or around the <u>18th August 2025</u> this will enable the village hall modernisation project to commence with full planning preparation

Should we not receive full grant funding from SZC grants awards panel the Parish Council Modernisation Committee will review all options and possibly a reduced scope of hall modernisation
